

**LICENSE AND INDEMNITY AGREEMENT**

**RECITALS**

- A. The Church is the owner of certain property, buildings, and facilities located at 104 S. Pineapple Avenue, Sarasota, Florida (the Church Facilities).

**NOW THEREFORE, the Church and the Licensee agree as follows:**

- 1. **License.** The Church hereby grants to the Licensee a non-exclusive license to use, under the terms set forth below, a portion of the Church Facilities more particularly described as follows (Premises).

4. **Numbers or Persons:** The number of persons that may attend any function of the Licensee on the Premises shall not exceed \_\_\_\_\_ without the express written consent of the Church.
5. **Parking.** The Church parking lots located on State Street, near Pineapple Avenue and at the rear of the Church on Mira Mar Court will **not** be available under this agreement unless specifically authorized by the Church.
6. **Insurance. Unless this provision is specifically waived by the Church** the Licensee agrees it shall provide comprehensive liability insurance in the amount of \$1,000,000 minimum, naming the Church as a co-insured and will cause the Church to be provided with such a certificate.
7. **Indemnity. Unless this provision is specifically waived by the Church,** in part or in its entirety, the Licensee agrees to return all items moved from their original location(s) back to the location from which it was moved. The Licensee also agrees to indemnify the Church against breakage, damage, or loss of any equipment and/or property belonging to the Church.
8. **Fees.** The Licensee agrees to donate to the Church the sum of \$\_\_\_\_\_ in consideration for the use of the Premises.
